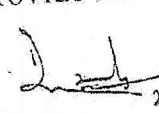
The Committee constituted for Compassionate Appointment for recommending suitability of candidates for compassionate appointment in the Ministry on compassionate ground was done on 13th March, 2024 by circulating the papers related to the applicants.

2. The Committee was informed on an earlier occasion that a requisition had already been sent to SSC for filling up the 37 vacant posts of MTS on direct recruitment basis. Further, as per the prevailing guidelines 02 vacancies have been earmarked for filling up on compassionate ground.

3. The Committee was also informed that the Ministry had called for applications from eligible candidates. In response, 12 applications were received in the Department from the family members of deceased employees. The Ministry has formulated a 100 points-scale marking system taking into consideration the economic conditions of the deceased family [pensionary benefits, pension, income, property, dependent members, etc] which will facilitate objective evaluation of candidates based on information provided by the candidates in their applications.

4. In order to adjudge the suitability of the candidates, the Committee has taken into consideration the issue of their eligibility for appointment on compassionate grounds and related issues. On the basis of practice being followed in various Ministries/Departments and instructions issued by DoPT, different attributes of the applicants were distributed to a Merit Point Assessment on a 100 point-scale adopted by the Ministry to ensure complete transparency.

5. The Committee evaluated the information available in the documents furnished by the applicants, compilation provided by Administration relating to deceased Government Servants based on the information provided by the Welfare Officers. Summary sheets in respect of all the 12 applicants containing points earned by each applicant, based on the criteria adopted, have been prepared and placed at Appendix. It is observed that the candidates are dependent family members of deceased employee pertaining to periods as early as July, 2004 to January, 2022. Since DoPT guidelines provide for considering

applications without any time limit, the Committee has decided to consider all applicants for the post of Compassionate appointment.

6. The Committee, considering the number of vacancies for compassionate appointment i.e 02, has decided that 3 applicants (including the reserve one) may be considered for compassionate appointment. Accordingly, the Committee taking into account the relevant guidelines and objective of compassionate appointments recommends the following top 02 Candidates in order of ranking in the assessment sheet for appointment against 02 vacancies as under along with a candidate in the reserve list:

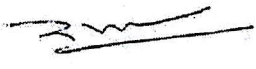

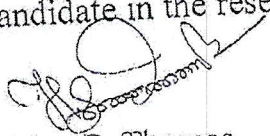

7. The offer of appointment to the recommended candidates on compassionate grounds will be provisional subject to the condition that if anything is found incorrect/misleading in the application form of the applicants, his/her candidature(s) will be withdrawn with immediate effect and submission of the required undertakings by the candidates.

9. If any candidate(s) is/are unwilling to join the post due to any reason or anything found incorrect/misleading against the provisionally selected candidates, then a provisional offer may be given to the candidate in the reserve list.
