I am directed to convey the sanction of President of India to the payment of **Rs.1,00,75,500/- (Rs.One Crore Seventy Five Thousand Five Hundred only)** as reimbursement of grant-in-aid for 100 ICCW run creches under the National Crèche Scheme for the period 01.04.2016 to 31.12.2016 as per the following details:

2. The sanction of funds is in compliance of the Hon'ble Delhi High Court's order dated 23.05.2017 in W.P.No.11116/2015 and is subject to the following conditions:

- i. State Government shall release funds only to those ICCW run crèches found functional for the period from 01.04.2016 to 31.12.2016.
- ii. State Government shall release funds only to the extent of verified expenditure.
- iii. State Government shall release funds directly to the NGOs running creches
- iv. Unspent grants, if any, will be adjusted during the release of next instalment grants of 2017-18.
- v. Further, as per the scheme guidelines and NITI Aayog guidelines, State Governments shall ensure that the NGOs running the crèches are registered in the NGO-PS portal and have furnished details of Unique ID from NGO-PS portal, Aadhar number, PAN number, mobile number, E-mail ID of the office bearers before release of grants.

3. The grant is further subject to condition that the State Government will maintain separate records of expenditure incurred for implementation of National Crèche Scheme and furnish separate Statement of Expenditure and Utilization Certificate.

4. The expenditure of **Rs.1,00,75,500/- (Rs.One Crore Seventy Five Thousand Five Hundred only)** is debitale to the 3601 (Major Head)-Grants-in-aid to State Governments, 06-Centrally Sponsered Schemes (Sub Major Head), 101-Central Assistance/Share (Minor Head), 47- ICDS (Sub-Head), 06- National Crèche Scheme (Detailed Head), 31-Grants-in-aid-General (Object Head) in Demand No.99, Ministry of Women & Child Development 2017-18 (Plan).

5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women and Child Development, D Wing, Ground Floor, Shastri Bhawan, New Delhi. **The payment of the State Government would be arranged through Reserve Bank of India, Nagpur.** The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.
